LAZARUS, COME FORTH

When Jesus approached the tomb where Lazarus had been buried four days previously, there was a certain amount of consternation when He commanded that the stone covering the opening of the tomb should be rolled away. Those nearby expected the stench of death and decay. They feared not only those sure smells of death but also the sight of decomposition that would have happened after the preparation of Lazarus' body for the burial.

Amid all these misgivings, Jesus voiced a prayer to God that what would happen next would glorify God. Since coming to Bethany, He had counseled both Mary and Martha concerning the resurrection. While they expressed belief in

a future resurrection, they were not prepared for an immediate one. He had previously given His disciples several lessons concerning His own future resurrection, now He would bring those lessons to mind as He called Lazarus forth to new life.

After the stone was rolled away, Jesus spoke clearly when commanding Lazarus to come forth. As Lazarus approached from His resting place, he was still bound in the graveclothes that had been put upon Him for his long sleep. The bindings of the graveclothes represented death as bondage. Sin and ultimately the grave binds those who allow themselves to be ensnared in Satan's Ways. Sin may seem frivolous and fun but will extract a much higher price.

Once Lazarus was freed of his graveclothes, he was free to serve God. Not long after this a meal was served in Bethany. Jesus was present but the person of interest was Lazarus. The curious and the concerned came to see the resurrected Lazarus. This should have cured any doubts about his resurrection.

While everyone was very interested in Lazarus, Mary was anointing Jesus' head and feet, preparing for His burial. Lazarus' resurrection was connected to Jesus' death and burial. She was preparing His body for that future burial. At the time of His death on the cross when His body was removed to be buried in the nearby tomb of Joseph of Arimathea, there was insufficient time for His body to be properly prepared for its burial. Mary's anointing service in Bethany had supplied that need.

From what little we know about Lazarus we would think that he was a good man. He was part of a family that provided friendship and fellowship to Jesus during His journey in the flesh in this world. He might remind each of us that while we might be considered to be good people, we are also sinners and will meet death at some point in our journeys. Since

none of us can rightfully claim to be perfect, we are all under the condemnation of sin. "The wages of sin is death." The degree of our sin or our reputation will not derail the final penalty.

Obviously, the time Jesus had spent with Simon's family had been fruitful in their belief and acceptance of what He had told them. They clearly believed in a resurrection. They were willing to honor Him, even at the cost of the precious ointment used to anoint Him. They sought His well-being when many religious leaders were seeking to eliminate Him. Some who were at the feast with Lazarus began to scheme how they could destroy both Jesus and Lazarus. Lazarus was a reminder to them of who Jesus is and what He had done.

Jesus' resurrection of Lazarus was one of many miraculous acts that He did during His earthly ministry. Through the power of the Holy Spirit He has continued to work miraculously in people's lives throughout the centuries since His return to Heaven. He has provided the rescue from the power of sin in our lives. His death, burial and resurrection have been implemented in our lives. He has made an offer of eternal life but

that becomes effective only when we were willing to accept the offer according to His terms. He desires that all would be willing to believe that He is the Son of God and that He has supplied the means of our salvation from the devices of Satan.

When Jesus called to Lazarus to come forth, Lazarus faced some inconvenience in moving out of the tomb while hindered by the graveclothes. Jesus commanded that he be set free from those impediments. He wants us to be free from the

impediments that hinder us from freely serving Him. He wants us to sacrifice ourselves for His honor, the glory of God, and the good of our neighbors. He wants us to serve freely not bound by self-interest, pleasure or profit.

As those who have been loosened from the bondage of sin and death, do we excite those around us as we remind them of what Jesus has done in our lives? Have we been loosed from the graveclothes of sin? Are we serving Him freely?

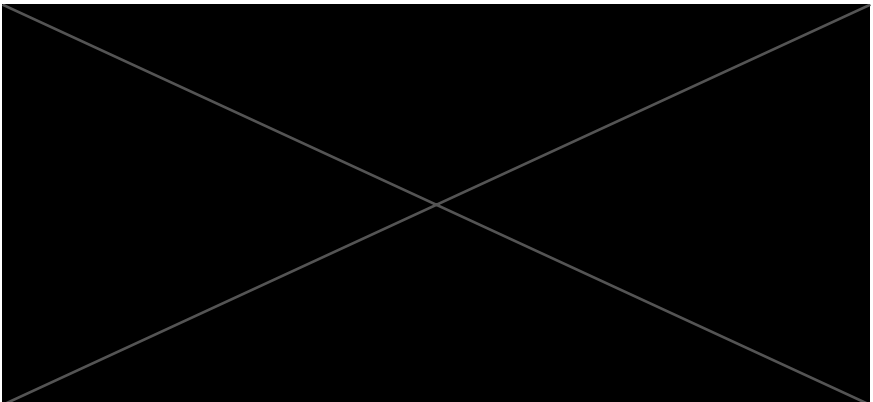
Continue in well doing, as our text has told us, that God may be glorified by the fruit of our relationship with Him.

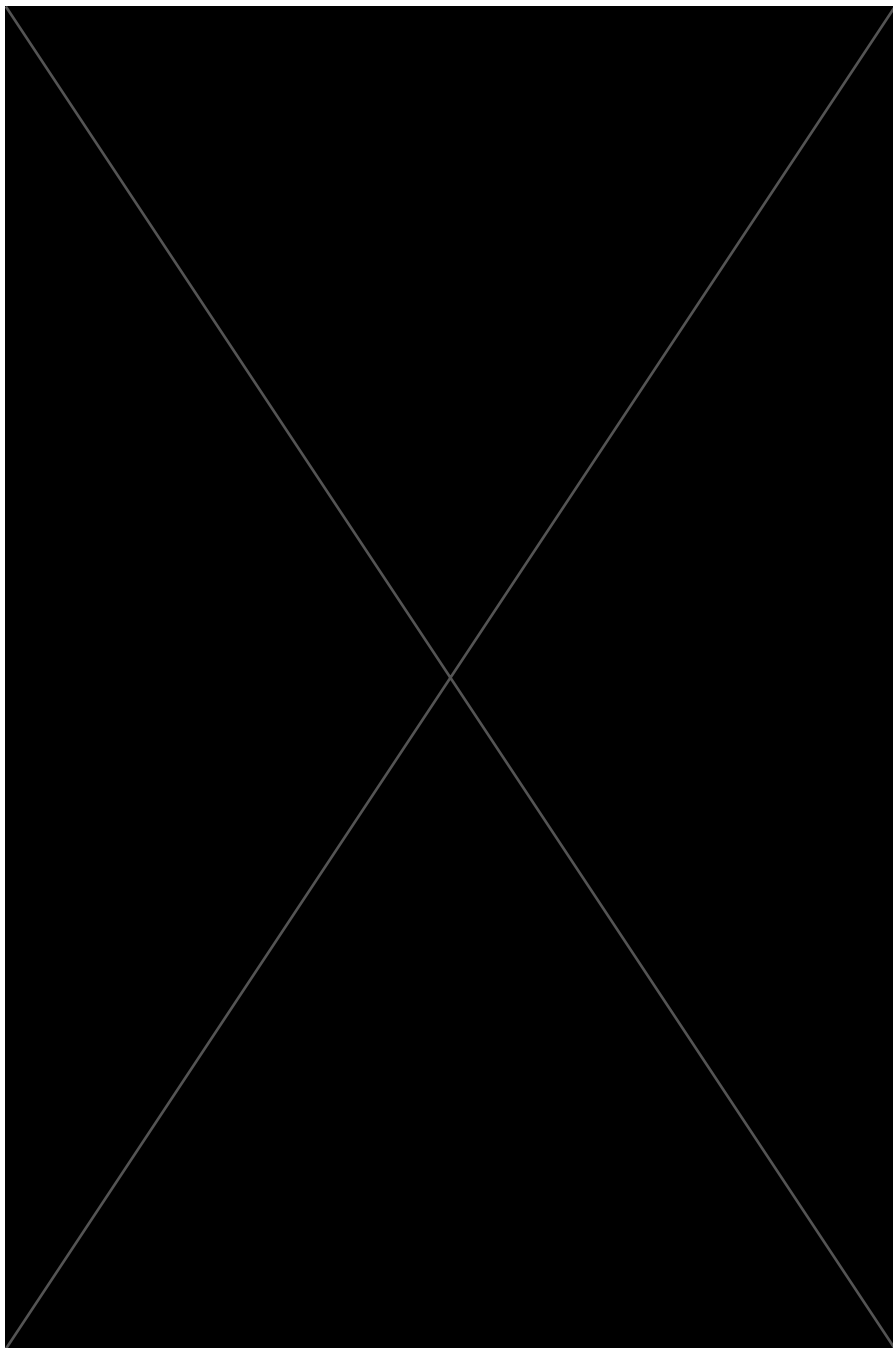

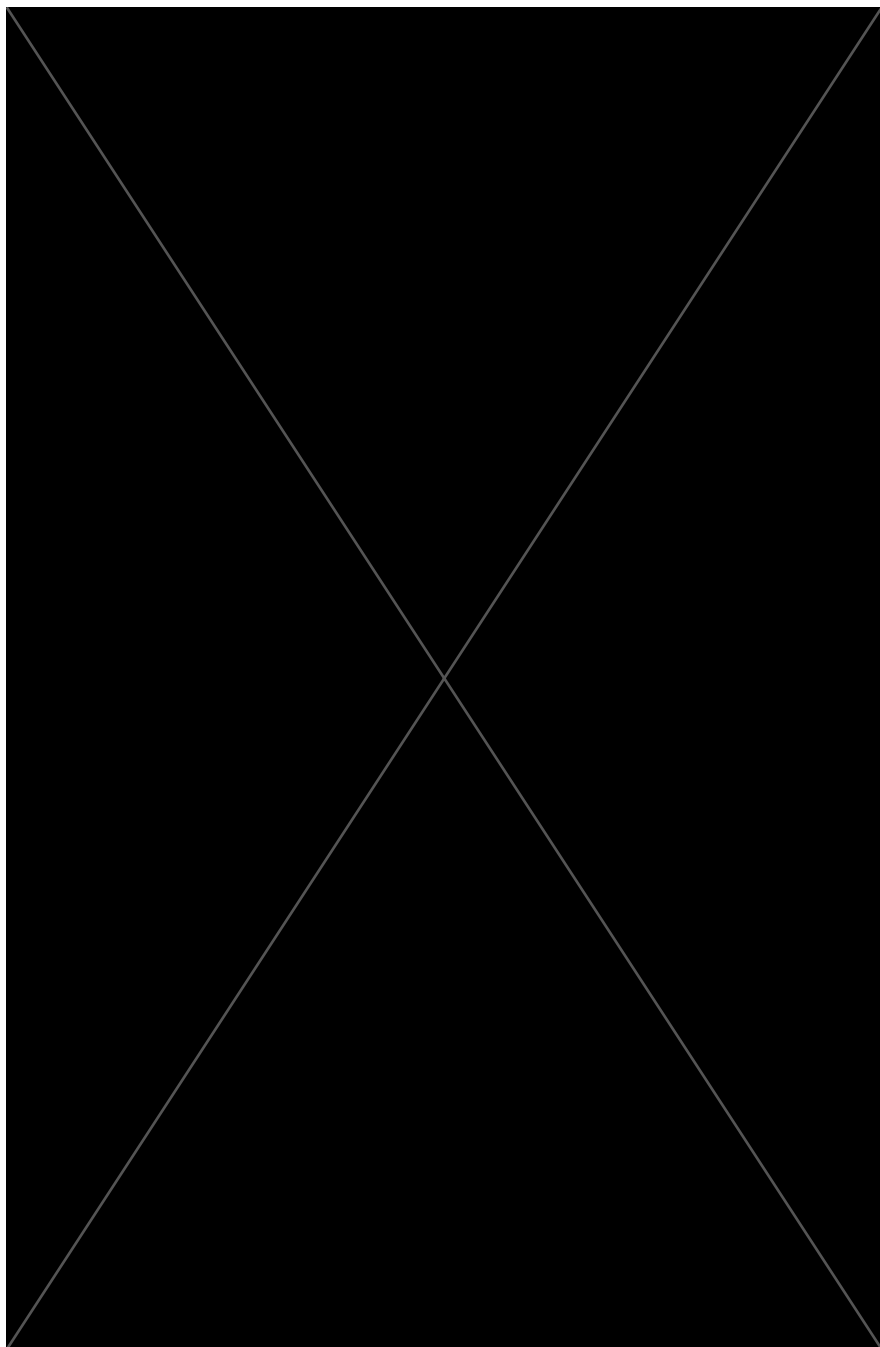

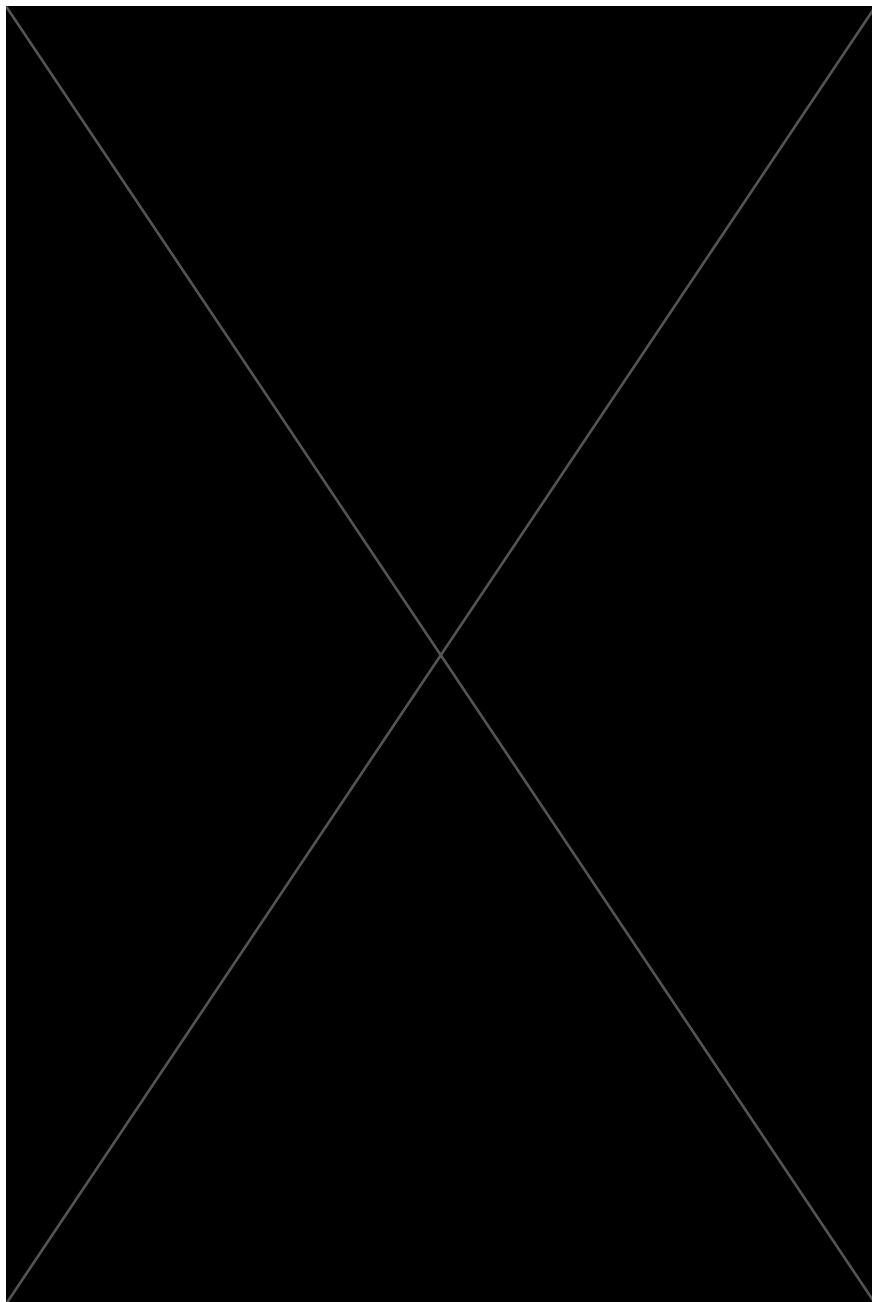

SUGGESTIONS TO CONTRIBUTORS

We are submitting several suggestions as a help to contributors in preparing material for the Bible Monitor. These suggestions will also make the work easier for both the editor and the writer.

1. Become familiar with the Editorial Policy and do not use subjects or statements, which conflict with this plan of the Bible Monitor.

2. Place your name and address at the close of the article.

We deem it more appropriate to sign as Brother or Sister.

3. Do not make sentences too long. A number of short sentences are better than a long, involved sentence, which is difficult to punctuate and in which the real meaning of the writer's thought may be lost.

4. It will be appreciated if you gather a particular thought or thoughts and their proving Scripture quotations into paragraphs. Set these apart from the rest of the article by setting in the first line of each paragraph about the space of three letters.

5. Do not crowd your words or punctuation marks close together. Do not use slang or abbreviated words such as, "thot" for "thought", "2" for "two", "&" for "and", "etc." for "and so forth".

6. Write or type on one side of the paper only. Double spacing of lines is much preferred. Do not make the lines the full width of the sheet, leave at least a one-inch margin on each side of the sheet.

7. Use direct quotations for the Scripture references. Please copy wording and punctuation just as it appears in the King James Version of the Bible. Given thus: book, chapter, and verse.

“Jesus wept.” John 11:35.

8. Frequent mistakes we find: “beleive” for “believe”; “recieve” for “receive”; “ore” for “or”; “&” for “and”.

9. In submitting selected material, give the name of the author and publication in which it appeared, if known, secure permission to use copyrighted material and add “selected by” and your name.

10. To be certain that an item is in a certain issue, your editor should have this item at least sixty days prior to the date of that issue.

11. The Publication Board has decided that News Items should contain material of general interest to the Brotherhood. Therefore, items of only local interest should not be included in News Items, such as local Sunday School officers, District Meeting delegates, minor local church property improvements and items, “In Memoriam”.

12. Read these, then write.

talking and writing about those matters.

B. When advice is sought of an official in any church matter, he (the official) should be exceedingly careful in giving advice, so as not to interfere in any way with proper care of difficulties, by officials whose business they are. Elders and all others should, in seeking advice, begin at home when at all possible and be careful to proceed regularly and in brotherly love.

C. In correspondence, care should be exercised not to make statements that may be construed as derogatory to any member.

If such things are done, full responsibility must be understood as being assumed by the writer.

D. Caucusing, that is the talking over and planning by groups, what to do or how to move in any particular matter is unprofitable, causative of distress and trouble and should not be indulged in by officials or anyone else.

E. Talking or circulating of what was done in council, either to members, who were not present, or to outsiders, is irregular and un-Christian and should not be indulged in.

LOCATION OF CHURCH HOUSES
